*The minimum accommodation charge will be calculated on the basis of a 5-day stay.

*Accommodation fees are charged at a 50% discount for vessels operating on the coastal route.

The accommodation fee is charged at a 25% discount to Turkish-flagged vessels operating on international routes.

During public holidays and national holidays, the accommodation fee is subject to a 50% surcharge.
